MAP is a non-profit organization established in 1989 to provide high-quality afterschool enrichment programs in Medfield. We do this through special subject clubs, physical activity, thematic programs, dramatic play, homework support, and projects tied to the MA Curriculum Frameworks. MAP is licensed by the Department of Early Education and Care for children in grades K-8.

Today, MAP is fully enrolled with 350 students from 270 families at our four facilities, employing 37 faculty and staff. MAP is supported by tuition and tax-deductible contributions from families, their employers, and other organizations.

The Quest

During our 22 year history, the Medfield Afterschool Program (MAP) has expanded its facilities to accommodate the needs of our families and the Medfield School system. Originally housed in the Medfield Memorial School Cafeteria, the program has grown to operate at four separate locations. Two of these sites are MAP-owned modular buildings at the Memorial and Wheelock schools.

The separate facilities are one of MAP's greatest strengths. At each site, we provide access to age appropriate gyms, playgrounds, libraries and cafeterias. Students are able to walk from school, avoiding added transportation costs and logistics for parents.

Construction industry professionals have inspected the buildings and developed a list of repairs that simply can't wait. In particular, the roof on the Wheelock modular needs replacing and brick facing at Memorial needs to be repaired and sealed. Our campaign goal of \$100,000 will cover these and other capital projects at both sites.

While the long-term need for space has been solved, we are on a quest to address significant maintenance and repair issues.

We know that childcare is a critical support system for working families. We also appreciate that you have come to rely on MAP to go beyond basic childcare to build life-long friendships and instill a love of learning in our kids. We do this with a dedicated and enthusiastic teaching staff that develops strong, positive relationships with students over time.

MAP is fiscally prudent, operating with a balanced budget. The bulk of our \$1.2M income (99%) comes from tuition while our net profit is less than 1/100th of one percent. There simply are no extra funds to address building issues.

MAP, in turn, needs to rely on you. We are on a quest to keep tuition affordable, continue to support our excellent teachers and provide exceptional enrichment programs, while addressing significant maintenance and repair issues.
